### **Notice Regarding the Status of Own Share Repurchase** (Repurchase of own shares, pursuant to the Company's Articles of Incorporation based on the provisions of Article 459-1-1 of the Company Law of Japan)

Nidec Corporation (TSE: 6594; OTC US: NJDCY) (the “Company”) today announced the status of the Company’s own share repurchase under its ongoing repurchase plan resolved at a meeting of the Board of Directors held on January 24, 2018, pursuant to Article 459, Paragraph 1, Item 1 of the Company Law of Japan.

#### **Details of Share Repurchase**

1. Period of own share repurchase: From February 1, 2018 through February 28, 2018
2. Class of shares: Common stock
3. Number of own shares repurchased: 14,000
4. Total repurchase amount: 225,380,000 yen
