Notice concerning partial amendments to the Articles of Incorporation

This is to notify you that by decision of the board of directors meeting held on April 24, 2009, we have added an item on the agenda concerning partial amendments to the Articles of Incorporation as follows for the 36th annual meeting of shareholders scheduled for June 23, 2009.

Details

- (1) Reason for making the amendments
 - Due to the enactment of supplementary provision Article 6 of (2004 Law No. 88) the Law Revising Part of the Law, etc. concerning the transfer for bonds, etc. in order to rationalize settlements related to stock and other transactions, we are considered to have made a decision to make amendments to the Articles of Incorporation to abolish the stipulations of the Articles of Incorporation on issuing stock certificates on the date of coming into effect (January 5, 2009) of the shift to electronic stock certificates. Therefore, the provisions of the current Article 7 (issuance of stock certificates) and Article 8 Paragraph 2 (non-issuance of stock certificates for shares less than one unit) are no longer necessary; hence, these are deleted. The numbers of other articles are changed, and other provisions are updated.
- (2) Details of the amendments
 The details of the amendments are as follows.
