Notice Regarding the Status of Own Share Repurchase

(Repurchase of own shares, pursuant to the Company's Articles of Incorporation based on the provisions of Article 459-1-1 of the Companies Act)

Nidec Corporation (NYSE: NJ) (the “Company”) today announced the status of the Company’s own share repurchase under its ongoing repurchase plan resolved at a meeting of the Board of Directors held on February 5, 2011, pursuant to Article 459, Paragraph 1, Item 1 of the Company Law of Japan.

Details are as follows:

Details of Share Repurchase

1. Period of own share repurchase: From August 1, 2011 through August 31, 2011
2. Class of shares: Common stock
3. Number of own shares repurchased: 380,000 shares
4. Total repurchase amount: 2,403,286,000 yen
5. Method of repurchase: Repurchased on the Osaka Securities Exchange through a trust established for this purpose.
